**PRLIMINARY STALLIONS
BREEDING CONTRACT, LIVE COVER
ONE BREEDING SEASON ONLY**

I hereby confirm my reservation for the stallion _____ for the breeding season of 2010 for the mare _____ Reg. No. _____, AHHA No. _____. I have enclosed the booking fee in the amount of \$200.00 and I understand that this booking fee is not refundable and is applicable to the breeding fee. The breeding season runs from April 1 through July 31 of each year. The stallion is standing at Rancho La Querencia LLC. This stallion has not been approved and/or licensed for breeding by the AHHA. Therefore, at this time, the foal resulting from this breeding is not eligible for AHHA registration and branding.

I understand that the total breeding fee of \$600.00 is due on arrival of the mare at Rancho La Querencia LLC and that the mare will not be bred until the breeding fee has been paid in full.

I agree to pay the guest mare boarding fee of \$10.00 per day each month in advance. This fee includes pasture board, daily care, and teasing. Veterinary, farrier, foaling, deworming, collection fees, stabling, and insemination fees are additional and are outlined on the enclosed Schedule of Breeding Fees. All fees incurred by mare must be paid before the mare may be removed from Rancho La Querencia LLC.

In order for the management and employees of Rancho La Querencia LLC to care for my mare, properly and safely, I herein supply additional comments on my mare, i.e. special care and feeding requirements, breeding behavior and/or problems, foaling problems, vices, lameness, etc.

I understand that the mare must be manageable and, if she has a foal by her side, that the foal must be halter broken, otherwise the personnel at Rancho La Querencia LLC will train the mare and foal at additional expense to the owner. If the mare proves dangerous to Rancho La Querencia LLC personnel or to the stallion, Rancho La Querencia LLC

reserves the right to refuse to breed her in which case the breeding fee, minus the booking fee, will be refunded.

The mare must be accompanied by:

1. A veterinarian's health certificate stating the following:
 - a. That she is free of all contagious and infectious diseases.
 - b. That she is breeding sound.
 - c. That she has been vaccinated within 2 months for strep, encephalitis (E,W,V WN), tetanus, influenza, rhino, and potomac horse fever.
2. A copy of her registration papers.
3. Proof of insurance and emergency information.
4. Breeding history.

I herein grant permission to secure the services of a veterinarian for this mare and/or her foal at my own expense in case of accident, illness, or injury or to further the possibility of pregnancy of the mare. I understand that I will be notified if possible of any necessary treatment.

If after the full breeding season of 2010 the mare for any reason does not produce a live foal which can stand and nurse, the mare owner must pay another breeding fee of \$600.00 in order to breed the mare for another season.

The above paragraphs are a departure from the usual American Breeding Contract. Please take note that the stallion's fee has been cut by 30% and that the contract is good for only one breeding season. If the mare fails to produce a live foal as stated above then another breeding fee must be paid before the mare is bred.

As the owner of the mare I fully understand that it is my responsibility to see that my mare is in sound breeding condition before breeding and that she remains in good condition to successfully carry a healthy foal.

Both parties to this contract fully realize the dangers involved in the handling and breeding of horses; therefore neither Rancho La Querencia, LLC, its owners, managers, nor employees, nor the stallion owner shall be held liable or responsible for the death, injury, disease, or accident to the mare owner, the mare, or to the accompanying foal. I hereby release them from any and all liability with respect thereto. Likewise, Rancho La Querencia LLC and the stallion owner hereby release the mare owner from any liability for the death, accident, or disease of or to the stallion or Rancho La Querencia LLC employees attributable to this mare during her stay at Rancho La Querencia LLC.

Should the stallion or mare die or become unbreedable after the time of service the contract may be transferred to another RLQ stallion or another mare, whichever is applicable, for the remainder of the 2010 breeding season only.

This contract cannot be assigned or transferred by the mare owner. Should this stallion or mare be sold no refund shall be due from Rancho La Querencia LLC under any circumstances.
